The tenure of the existing Campus Student Grievance Redressal Committee at the Viman Nagar Campus/Location of Symbiosis International (Deemed University), Pune, shall stand concluded with effect from the date of notification of this newly constituted committee.

The term of the Chairperson and Members of the committee shall be two years, i.e., from 17th January, 2026 to 16th January, 2028.

The term of the Special Invitee of the committee shall be one year, i.e., from 17th January, 2026 to 16th January, 2027.

A Member shall cease to be a Member of the Committee as soon as he/she ceases to belong to the category from which he/she was nominated to the Committee.

The powers, functions, and procedures to be followed for the meeting(s) of the constituted Campus Student Grievance Redressal Committee at the Viman Nagar Campus/Location of Symbiosis International (Deemed University), Pune, shall be in accordance with the rules notified and as amended from time to time.
