Aims and Objectives:

To oversee the effective implementation of policies and programmes for disadvantaged groups, to provide guidance and counselling with respect to academic, financial, social and other matters and to enhance the diversity within the campus.

Functions:

1. To ensure equity and equal opportunity to the student community in the constituents and bring about social inclusion.
2. To enhance the diversity among the students, teaching and non-teaching staff population and at the same time eliminate the perception of discrimination.
3. To create a socially congenial atmosphere for academic interaction and for the growth of healthy interpersonal relationships among the students coming from various social backgrounds.
4. To make efforts to sensitize the academic community regarding the problems associated with social exclusion as well as aspirations of the marginalized communities.
5. To help individuals or a group of students belonging to the disadvantaged section of society to contain the problems related to discrimination.
6. To look into the grievances of the students from the weaker section of society and suggest amicable solution to their problems.
7. To disseminate the information related to schemes and programmes for the welfare of the students from socially weaker section as well as notifications/memoranda, office orders of the Government, or other related agencies/organizations issued from time to time.
8. To focus on overall personality and skill development, including professional and soft skills, so as to ensure enhancing the student employability.
9. To hold regular meetings with Social Economically Disadvantaged Groups (SEDGs) students to check their grievances and also meet with management/authorities of HEIs to facilitate discussion of the grievances of SEDG
10. Coordinate with the Internal Quality Assurance Cell (IQAC) to raise awareness about the implementation of various policies for inclusive and equitable quality higher education.
11. To establish a team of counsellors, social workers, and faculty members to provide emotional and social support to SEDGs to adapt to the environment of the HEI.
12. To provide socio-economic, academic, and emotional support and mentoring for such students through proper counselling and mentoring programmes.
13. To prepare barrier free formalities/procedures for admission/ registration of students belonging to the disadvantaged groups of society.


